Re: Official Information Act request e-scooters ED presentations

I refer to your Official Information Act request dated 17 December 2019 requesting the following information.

We have updated our response to you as we initially did not provide all the information in the form you requested, which we apologise for.

Please note that while you have asked for information relating to e-scooter injuries, injuries related to e-scooters are not coded as such and therefore accurate data is not available. Extracting this information would require a review of clinical notes which would require substantial collation and research.

Instead, the information provided has been extracted from data in the ACC claim forms. The data may also include injuries caused by mobility scooters or push scooters. Furthermore, all ACC claim forms for December 2019 have not been completed, therefore, the total number of e-scooter related presentation may be higher than provided.

I was hoping to get some statistics on presentations to the emergency department related to escooters since Lime and Wave have been unable to operate in Auckland (December 3) and how this compares to the average when they were operating.

My questions are:

1. How many presentations relating to e-scooter injuries has the hospital emergency department seen since December 3? (Broken down by week)
