Re: Official Information Act request – Capital expenditure for the last ten years

I refer to your Official Information Act request dated 30 January 2020 requesting the following information.

Please supply the following information under the Official Information Act (OIA):

- 1. What was your DHB's capital expenditure of the last ten years.
- 2. What capital has your DHB spent on infrastructure over the last ten years.
- 3. What was the source of the funding spent on capital expenditure during this time period.

Our responses are provided in Table 1 below:

1. Total Capital Expenditure (Capex) for the last ten years amounts to \$482.468 million as summarised in Table 1 below.

Note: The negative expenditure lines in the IS/IT asset category reflect the transfer of assets developed by Auckland DHB to the northern region DHBs' shared services provider, healthAlliance.

- 2. The amount spent on infrastructure is not readily available from our records. However, infrastructure assets fall under the Building & Plant asset category shown in Table 1 above. The total spend on this asset category for the past ten years is \$226.899 million and this includes spend on facilities upgrades and refurbishments including on infrastructure. More recently, the DHB is implementing a Facilities Infrastructure Remediation Programme (FIRP) of which the Tranche 1 project approved by the Crown has a capital cost of \$305 million.
- 3. The funding source for the Capex for the past ten years is made up of the following (refer to Table 1):
 - \$406.783 million DHB cash;
 - \$45.561 million donations;
 - \$11.332 million lease financing; and
 - \$18.792 million Crown Equity.
