Re Official Information Request – Mental health transgender data

I refer to your official information request dated 3 August 2020 requesting the following information:

1. Number of mental health inpatient facility beds at DHB, by name of facility.

Auckland DHB has five inpatient/residential facilities. As indicated below, two of these are for the Auckland DHB population, and three service other DHBs also.

2. Number of people admitted as mental health inpatients who identify as transgender or gender diverse in the last 12 months.

The table below provides data for questions 2 and 3. Data is for the 12 months, 1 August 2019 to 31 July 2020. Both the number of unique individuals admitted is provided, as well as the number of admissions in total (some people will be admitted on more than one occasion).

In order to provide data on the number of transgender or gender diverse individuals admitted during this time, we have relied on some locally collected data, together with the recollection of senior leaders within the service. Because of this, and due to there being no central system for collecting this information, the data may not be completely reliable.
