

Chemist Warehouse


Chemist Warehouse is an Australian provider who has noted its intention to enter in to the New Zealand community pharmacy market and grow its presence rapidly. They have opened their first store in St Lukes and have a second planned to open in South Auckland early in 2018. They are reported as stating they intend to have up to 10 pharmacies in metropolitan Auckland.


Chemist Warehouse presence in New Zealand further reflects the shift in community pharmacy ownership models already seen. Greencross Healthcare have had a strong presence here for many years. Greencross fully own or have shareholding in numerous community pharmacies. More recently both Countdown and Nirvana have been expanding their pharmacy networks. It is unclear as to what long term impact these new ownership models will have. However, competition within the community pharmacy sector looks to be strong for the next several years while these players continue to make their presence felt. It is expected that some existing community pharmacies may become less viable and may lead to some closures. Considering that there are over 300 community pharmacies in metropolitan Auckland the closure of some is unlikely to have any material effect on patient access. The Funder will monitor any closures to ensure that patient access is not unduly compromised.

Chemist Warehouse heavily discounts and appears to work on a high volume low margin basis leveraging off their bulk purchasing power. Noting that in Australia Chemist Warehouse is the sixth largest retailer in Australia with an annual turnover of A\$4.4 billion (NZ\$4.7bn) in 2016, and the biggest online pharmacy retailer in Australia. Further Chemist Warehouse are fully discounting the prescription co-payment of \$5. The removal of the prescription co-payment and lower cost to over the counter medicines helps address one of the barriers to medicines for those least able to pay.

As with all pharmacies they are all licensed by Medicines Control, Ministry of Health, and as such meet the required standards. There is no evidence that these 'corporate' pharmacies provide service of a quality any different to that of independently owned pharmacies.

There is no apparent risk with this new market entrant, in fact patients look likely to benefit from a cost perspective.
