I refer to your Official Information Request dated 3 November 2020 requesting the following information:

I am requesting for Attention Deficit Hyperactivity Disorder (ADHD) and Autism Spectrum Disorders (ASD) information/statistics that you may have.

The following data is from services provided by the Mental Health and Addictions Directorate only. This does not include data on people who may have been diagnosed with ASD or ADHD in other Auckland DHB services, such as Child Health. This is because outpatient activity in these services is not coded in Auckland DHB and so diagnoses are not recorded or entered into a data set. The diagnosis of ASD and ADHD is not made as an inpatient.

Unfortunately we are unable to provide information back to 2000 as requested. The data below is from 2008 to 2019 inclusive. The reason for this is that the information has been extracted from the national mental health data collection (PRIMHD), which began in 2008. To go back to 2000 would have involved a more manual retrieval which would involve substantial collation and research; therefore we are declining this section of your request under section 18(f) of the Official Information Act.

You have asked for residential area. All information below relates to the population within the Auckland DHB catchment area.

Please note that all data relates to the year in which an individual was first diagnosed, and individuals are only counted once. That is, if someone first presented or was first diagnosed in 2008, but continued to be seen by services in 2009, they will only be counted in 2008 and not in 2009 or outlying years.

The diagnoses included in this data are limited to those coded as the principal or other relevant mental health diagnosis, as per the PRIMHD diagnosis types.
