

Re Official Information Request – How many anaesthetic technicians employed by ADHB

I refer to your official information request dated 30 June 2020 requesting the following information:

Pursuant to section 12 of the Official Information Act 1982 the Association of Professionals and Executive Employees requests the following information:

- 1. How many anaesthetic technicians are employed by the DHB and for each technician please provide the following:
  - > their FTE.
  - > their length of service as per their employment agreement, and
  - what step on the salary scale they are paid, and
  - > what the salary for the step they are on is;

Data is included in Excel which is as at 30 June 2020 (attached).

2. How much anaesthetic technician FTE is currently vacant at the DHB;

Currently we are recruiting for 3.5 FTE of vacant positions for Anaesthetic Technicians as at 10 July 2020.

3. The number of anaesthetic technician trainees currently employed at the DHB;

28 positions are filled by Anaesthetic Technician Trainees as at 30 June 2020. This includes 2 positions that are called Registered Nurse/Trainee Anaesthetic Technicians.

4. The number of Maori and Pacifica anaesthetic technicians and trainees (identified separately) are employed at the DHB;

6. How much has been spent on locum and contractor anaesthetic technicians in the 12 months from 1 June 2019 to 1 June 2020. This will include all salary, wage or contractor fees as well as incidentals such as recruitment costs, travel and accommodation for such individuals.

The amount of money spent on staff paid under a casual contract Anaesthetic Technicians for salary and wages is \$40.8K. We cannot provide a further breakdown of this cost as it would require substantial collation and research as per clause 18 (f) of the Official Information Act.
