Re: Alcohol Related Harm Auckland DHB Ref 20220419-1206

I refer to your official information request transferred to us by the Technical Advisory Services (TAS) on 19 April 2022, requesting the following information:

"I am requesting the following information under the Official Information Act from all DHBs within New Zealand about alcohol harm. Is it possible for this to be forward to all relevant parties if the information is not centralised. This follows on from an OIA made in 2020 but updated statistics will be invaluable to research efforts.

- Please provide a yearly breakdown of how many people were treated from 2012-2022 (to date) for alcohol related harm
- 2. Please provide a yearly breakdown of age groups of those treated in your DHB between 2012-2022 for alcohol related harm.
- 3. Please provide a yearly breakdown of the ethnicity of those treated in your DHB from 2012-2022 for alcohol related harm.
- 4. Please provide a yearly breakdown of age groups of those admitted to your DHB from 2012-2022 for alcohol related harm.
- 5. Please provide a yearly breakdown of ethnicity of those admitted to your DHB from 2012-2022 for alcohol related harm.
- 6. Please provide a yearly breakdown of age groups of those admitted to your DHB from 2012-2022 for alcohol related harm.
- 7. Please provide a yearly breakdown of the cost for each person treated / admitted in your DHB for alcohol related causes.
- 8. Please provide a breakdown of how many patients were admitted to Emergency Departments where alcohol was determined to be a factor in their admission from 2012-2022"

## Response

We have provided the information under each of your questions below. The response focuses on in-patient or emergency events, which appears to be what you are requesting. If you are interested in information about community drug and alcohol services, we note that Waitematā DHB provides our outpatient alcohol treatment services. That DHB has been advised and will providing that data with its response. The contact person there is OIA Manager Denise Poole Denise.Poole@waitematadhb.govt.nz

The data in the tables below for questions 4, 5 and 7 represents patients with an alcohol-related coded diagnosis. Please note that only patient events longer than three hours are coded upon

discharge. These tables include both emergency department and non-emergency department events.

The calendar year 2022 includes patients admitted up to and including March, but note March figures may be lower as not all patients admitted will have been discharged and coded. Costing data for 2022 has not been provided as the costing data for the first three months of the financial year has not been finalised. We are refusing this part of your request citing s 18 (e) Official Information Act – the information does not exist. We could, if you wished undertake to follow up with you and supply it when it is finalised. This would be in several months' time.
