(Birth (including place of birth) and milestones, childhood, schooling / education, employment & finances, relationships, cultural, spiritual, housing, sexuality, any other significant events)

Trauma History

(Emotional, physical, sexual abuse, neglect, abandonment, witnessing violence, refugee, loss/bereavement, bullying, poverty, stigma/shame, estrangement from culture destructive or constructive coping methods. Experiences in services of trauma/ re-traumatising. Situations/triggers known to re-traumatise.)

Culture

(Cultural identity, Iwi. Include past input from specialist cultural services, need for Interpreter, language, person's relationship with their cultural heritage – sense of belonging/identity? Desire to reconnect or increase cultural knowledge?)

Family History

(Mental health, suicide, substance use, where-abouts of family, age at time of death, supportive relationships, estranged relationships, involvement with wider whanau, person's sense of belonging in family? Wanting family involvement?)

Drug and Alcohol and Addiction History

(Alcohol, other drugs, gambling, tobacco smoking – amount used and consequences of use. Attempts to manage addiction? Periods of managing addiction and what was occurring to support this?)
